

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Talgarth Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Underlying records to support grant claims

As part of our testing of income we examined records relate to TADSCA grants. We identified that there is limited documentation around the grant.

We recommend that the Council retains full documentation to support all grants claimed.

Staff costs

The reported staff costs include items other than remuneration of staff e.g. tax paid on members allowances.

We recommend that the Council ensures that it appropriately classifies expenditure in accordance with proper practice set out in the Practitioners' Guide.

There are no further matters I wish to draw to the Council's attention.
